    - C. Gardner provided a presentation that covered the three items noted under 6.1.
    - C. Gardner presented the Board's legislated mandate and responsibilities including the levies of the four obligated municipalities as well as the commitments, pressures and risks.

6.1.3 One-time & Enhanced Base Funding Requests – 2019 Draft Budget and Grant Submission.

The proposed 2019 budget and grant submission includes 10 submissions for one-time funding totaling \$918,800, 5 submissions for base funding totaling \$1,235,000 and infrastructure renewal grant requests (CIRF) totaling \$176,500.

The deadline to submit the 2019 Budget to the Province is March 1, 2019. Certain one-time costs are admissible expenditures for grant funding from the province and will be considered for approval as one-time grants only. One-time funding requests will only be considered by the province if they are submitted with the program based grants request by March 1, 2019.

Submissions to the Province do not require items to be prioritized as they are reviewed and ranked based on criteria developed by the Province.

Board members requested information around cannabis enforcement. S. Rebellato identified that under the SFOA Act, SMDHU responds to enforcement issues as they are identified from municipalities. C. Gardner noted that the health unit is not responsible for monitoring the cultivation of cannabis and performs the role of issues related to smoke exposure, tobacco and vaping.

- R. Cipolla indicated that the City of Orillia recently passed a bylaw that takes effect at the end of March that identifies all cityowned properties will be smoke-free.
- P. Willmott discussed the alPHa resolution that was submitted titled: A Comprehensive Approach to Infection Prevention and Control (IPAC) in Regulated Health Professional Settings. C. Gardner will follow up with L. Ryan, Executive Director of alPHa and report back to the Board of Health regarding the status of the motion.
